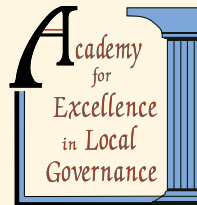

Chief Laretta Hill's 23 years in law enforcement has included: Police Commissioner of Public Safety and Security for Dallas County Community College District and Deputy Chief of Police, Miami Beach. In that capacity Chief Hill was responsible for 490 sworn and non-sworn personnel and oversaw a \$100 million annual operating budget. During her tenure she restructured the entire department to align with department's vision, mission, and values. She reemphasized the value of community policing and introduced concepts of police legitimacy.

Laretta holds a Bachelor's of Arts Degree in Criminology/Criminal Justice from the University of Texas and a Master's of Liberal Arts Degree in from Texas Christian University. She is a graduate of FBI National Academy and the Police Executive Research Forum (PERF) Senior Management Institute for Police. Laretta is also a member of the International Associations of Chiefs of Police (IACP), National Organization of Black Law Enforcement Executives (NOBLE), and PERF.

Laretta has received the Distinguished Service Award, Officer of the Year Award, proclamation from the Texas State Senate, Distinguished Alumni Award, and Community Service Awards for her commitment to the law enforcement profession.
