Driving Directions:

March 22 - Town of La Plata, Town Hall: Take exit 9A for Balt./Wash. Pkwy./MD-295 toward Washington. Merge onto MD-295 South. Take I-495 S./I-95 S. toward Richmond Va. Take exit 7A for Branch Ave./MD-5 toward Waldorf. Merge onto MD-5 South. Continue on Crain Hwy./US-301 Turn left at Charles St. Turn right at LaGrange Ave. LaGrange Ave. turns right and becomes Queen Anne St.
End at: 305 Queen Anne Street, La Plata, MD 20646

April 3 - Town of Denton, Wharves of Choptank Visitor and Heritage Center: From I-97 S. toward Annapolis merge onto US-301 N./US-50 E. toward Annapolis/Bay Bridge (Partial toll road). Use the right 2 lanes to take US 50 E. exit toward Ocean City. Follow US-50 E. and MD-404 E. to Gay St in Denton. Continue onto US-50 E. Use the left 2 lanes to turn left onto MD-404 E. Keep right to continue toward MD-404 BUS E. Merge onto MD-404 BUS E. Continue straight onto Market St. Sharp left to stay on Market St. Continue straight onto Gay St. End at: 3 Crouse Park Lane, Denton, MD 21629

April 10 - Town of Perryville, Town Hall: From I-95 N. take exit 89 to merge onto MD-155 E. toward Havre De Grace. Continue on MD-155 E. Take US-40 E. to Broad St. in Perryville. Merge onto MD-155 E. Turn right onto Ohio St. Sharp left onto US-40 E. (Partial toll road). Pass by McDonald's (on the right). Turn right onto Aiken Ave (Partial toll road). Turn right onto Broad St. Destination will be on the right. End at: 515 Broad St, Perryville, MD 21903

April 11 - LGIT, Hanover: Take 295 S. to Rt. 100 W. to exit 8 Coca Cola Drive. At the traffic light make a right. Proceed to the second traffic light and make a right onto Park Circle Drive. Stay in the left lane and follow Park Circle Drive. Bear left at the stop sign on Parkway Circle Drive and make an immediate right on Standard Drive. Take 1st right. End at: 7225 Parkway Drive, Hanover, MD 21076

April 12 - La Vale, Best Western: Merge onto I-70 W. towards Frederick. Take exit 1A on the left to merge onto I-68 W./US-40 W. toward Cumberland. Take exit 39 for US-40 Alt W. Turn left onto US-40 Alt W./National Hwy. Make a U-turn. Destination will be on the right. End at: 1268 National Hwy., La Vale, MD 21502
