Driving Directions:

March 17 - City of Havre de Grace, City Hall: Take I-95 N. and continue straight to stay on I-95 N. (toll road). Keep left at the fork to continue on I-95 Express Toll, follow signs for I-95 N. Take exit 89 to merge onto MD-155 E. toward Havre De Grace. Continue straight onto Superior St. Superior St. turns right and becomes N. Juniata St. Turn left. Destination will be on the right. End at: 711 Pennington Ave. Havre De Grace, MD 21078

March 18- Town of La Plata, Town Hall: Take MD-295 S./Balt./Wash. Pkwy. toward Washington and continue onto Baltimore-Washington Pkwy. Take the exit onto I-495 S./I-95 S. toward Richmond VA/Andrews A.F.B. Use the right 2 lanes to take exit 7A-7B for MD-5 S. toward Waldorf. Follow MD-5 S. and US-301 S. to Queen Anne St. in La Plata. Use any lane to turn slightly right onto MD-5 S./Branch Ave. Continue to follow MD-5 S. Continue onto US-301 S. Turn left onto Centennial St. Turn right onto St Mary's Ave. Turn left onto Queen Anne St. Destination will be on the right. End at: 305 Queen Anne St., La Plata, MD 20646

March 19 - Cambridge Yacht Club: From Rt. 50 E. Cross the Frederick C. Malkus Jr. Bridge. Make a right at the 1st light onto Maryland Avenue. Cross the Cambridge Creek Bridge and make a right at the 2nd traffic light onto High Street. Proceed to Water Street and make a left. Take Water Street to Mill Street and make a right into the Yacht Club. End at: 1 Mill St., Cambridge, MD 21613

April 7 - LGIT, Hanover: Take 295 S. to Rt. 100 W. to exit 8 Coca Cola Drive. At the traffic light make a right. Proceed to the second traffic light and make a right onto Park Circle Drive. Stay in the left lane and follow Park Circle Drive. Bear left at the stop sign on Parkway Circle Drive and make an immediate right on Standard Drive. Take 1st right. End at: 7225 Parkway Drive, Hanover, MD 21076

April 9 - La Vale, Holiday Inn: Merge onto I-70 W. toward Frederick. Take exit 1A for I-68 W./US-40 W. toward Cumberland. Continue onto I-68 W./US-40 W. to exit 40 for Vocke Rd. Take Simpson Ave. and Asbury Ave. to your destination. Turn left onto Braddock Rd. Continue onto Campground Rd. Turn right onto Simpson Ave. Simpson Ave. turns left and becomes Asbury Ave. Destination will be on the left End at Holiday Inn, 1076 National Hwy., La Vale, MD 21502
